Policy of Intellectual Property Rights -2016

1. While creating intellectual property such as books, research articles, Industrial designs, copyrights, patents, etc., the affiliation of the college should be recorded in front of your name.
2. College address should be used whenever possible, while registering Intellectual Property Rights with Government of India and other countries.
3. While creating intellectual property such as books, research articles, industrial designs, copyrights, patents, etc., while registering do not use any short form of the college name, the name and address of the college should be used as given below:

4. Since creation of intellectual property is a matter of talent, permission of the college will not be required for creation of intellectual property.
5. The college may provide financial assistance whenever possible for the registration of intellectual property but the prior permission of the principal will be required.
6. As an incentive to increase the registration of intellectual property, after Registration at the national level, the institute will felicitate the inventor with shawl and sreephal.
7. The inventor shall retain the right to confidentiality regarding the invention while the process of registration of intellectual property is pending. Although permission is required in this regard, there will be no need to disclose the search.

8. Whenever possible special leave will be provided by the college for creation and registration of intellectual property. Hon'ble Principal will grant such leave as working leave.
9. 10% of the royalty earned by the researcher will be given to the college.

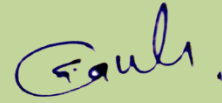
