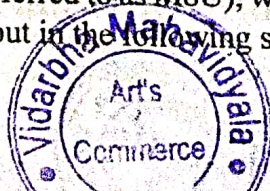

Preamble: SPM Tatyasaheb Mahajan Arts and Commerce College, Chikhli Dist.Buldana and Rajeshwar Education Society Buldana's Vidarbha Mahavidyalaya Buldana.443001.They have some areas of common interest in Higher Education in the subject of Arts and Commerce, considerable advantage may be gained from their pursuit on a collaborative basis in the fields of academic, education, research. Now, therefore, both institutes have decided to enter into this Memorandum of Understanding (hereinafter referred to as MoU), which defines the framework for the cooperation of the two institutions set out in the following sections.



NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERETO AGREE AS FOLLOWS:

ARTICLE 3: CONFIDENTIAL INFORMATION:

Both institutes do not absolve any confidential information during the collaborative activities.

ARTICLE 4: INTELLECTUAL PROPERTY RIGHTS:

Ownership of any intellectual property (including but not limited to confidential information, know-how, patents, copyrights, design rights, rights relating to computer software, and any other industrial or intellectual property rights) developed jointly during the course of this MOU shall be vested in both institutes to this Memorandum.

ARTICLE 5: VALIDITY :

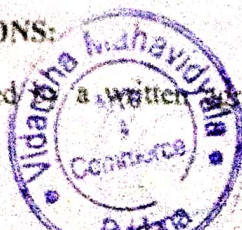
The Memorandum shall remain in force for a period of FIVE years commencing from effective date. Institutions may extend the term by written agreement signed by both after review.

ARTICLE 6: TERMINATION:

Either institution may terminate the MoU by giving written notice of one months in advance to the other institution.

ARTICLE 7: AMENDMENTS/MODIFICATIONS:

This MoU may be amended or modified by a written agreement signed by the representatives of both institutes.



ARTICLE 8: ADHERENCE TO LAWS:

Participating faculties, staff and students involved in any activities under this Memorandum must adhere to the law of the host countries and rules and regulations of the institutions.

ARTICLE 9: LEGAL EFFECT:

Nothing in this Memorandum shall be construed as creating any legal relationship between the institutes. This Memorandum is a statement of intent to foster genuine and mutually beneficial collaboration.

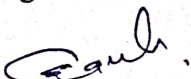
ARTICLE 10: DISPUTE RESOLUTION:
